**NOTIFICATION**

The Governor of Arunachal Pradesh is pleased to order the re-structuring of the 'Chief Minister's Paryatan Vikas Yojna' scheme as per the following new guidelines with immediate effect :-


**Background :**

It has been observed that many of the beneficiaries who have availed the Chief Minister's Paryatan Vikas Yojna (CMPVY) scheme are not using the vehicles purchased under the scheme as tourist cabs, but rather use the vehicles for their personal purposes.

It has also been noticed that many of the vehicles under this scheme bears no sign of any stickers on their vehicles in spite of repeated warnings to them by the department as well as by the Deputy Commissioners in the districts. And even if the stickers are pasted on their vehicles, it is easily removed by the owner. Hence, it is very essential to restructure the innovative scheme in a bid to take it to a more tourist- friendly scheme.

**Scope of the Scheme (new) :**

The entire State is endowed with thick forests with numerous rivers and many flora and fauna. The five rivers of the State, namely- Kameng, Subansiri, Siang, Lohit and Tirap flow their way through the green hills. Its rivers are ideal for angling, boating and rafting and its terrain is suitable for trekking, hiking and other various types of adventure sports activities. Thus, the higher reaches offer an ideal landscape for promoting adventure tourism of all kinds. It is because of such great scope that the State has vast untapped adventure tourism potentials. Accordingly, it was felt that the Chief Minister's Paryatan Vikas Yojna needs to include adventure tourism also as one of the components of the scheme.

**Mode of Re-structuring the Scheme :-**

Instead of subsidizing tourist vehicles to the beneficiaries, the Tourism Department proposed to finance the following tourism activities under the scheme:-

- (i) Patisserie and food courts in popular tourist spots and important towns / tourist places of Arunachal Pradesh.
- (ii) Value addition to Home stay operators which includes renovation of 2 (two) adequately sized well furnished rooms with attached toilet with shower, geyser and western toilet
- (iii) Purchase of various types of adventure tourism equipments such as rafts, kayaks, Quad bikes, lorbs, lip lines, Bungee jumps, etc.

**Selection of beneficiaries :-**

The selection of beneficiaries shall be done based on the following manner:-


**(i) Under Home stay :-**

The beneficiaries shall be selected initially from the following districts/ areas:

- (a) Tawang region
- (b) Bomdila region
- (c) Seppa region
- (d) Ziro region
- (e) Mechuka region.

Essential requirements to become a beneficiary of the scheme are as under:-

- a) Beneficiaries should be Home Stay operators registered with the Department of Tourism.
- b) Those Home Stay operators who have trained with the Department of Tourism will be given priority.
- c) Beneficiaries should be a registered tour operator with the Tourism Department.
- d) Beneficiaries should be registered tour operator with minimum of 30 (thirty) PAP processed with the department during last one year.

- e) Selection will be done by Deputy Commissioner. Department will send a list of registered Home stay and eligible tour operator of the district. Selection of beneficiary will be done by way of lottery from amongst this list only.


(ii) Patisseries and food court :-

The following important tourist spots/ destinations/ towns/ centers have been initially proposed for opening of food courts which could be extended to other places in due course of time. The selection of the beneficiaries for the Home stay and Hunar Se-Rojgar Tak (HSRT)/ bakery/ Patisserie will be done district-wise which would include:

(1) Itanagar Capital Complex area (2) Ziro & Hapoli towns (3) Bhalukpong town (4) Nagmandir town (5) Rupa town (6) Bomdila town (7) Dirang town (8) Padma area (9) Sela Pass area (10) Tawang town (11) Sangetser lake (12) PTSO lake (13) Seppa town (14) Daporijo town (15) Aalo town (16) Malinithan area (17) Mechuka town (18) Pasighat town (19) Roing town (20) Bhismaknagar area (21) Parasuramkund area (22) Tezu town (23) Hawaii town (24) Namdapha area subject to clearance by Forest Department (25) Jairampur town preferably near WW-II War Cemetery (26) Nampong Village near Lake of no-return (27) Khonsa town.

The selection of beneficiaries will be done from amongst the Hunar-Se-Rojgar Tak (HSRT) trainees of the districts as per the districts/ towns/ tourist centers mentioned below:-

**(iii) Adventure tourism equipments :-**


In this sector, the purchase on adventure tourism equipments such- as zorbs, quad bikes, rafts, kayaks, etc shall be done. Tour Operators who have processed more than 30 PAPs annually will be eligible for this. Selection will be done by the Department by a committee comprising of the following officials. Selection will be by way of lottery :-

**Fund Provision under the Scheme:-**

As regards to fund provision, an amount of Rs.500.00 lakhs (Rupees five hundred lakh) only have already been allotted by the Govt. for the purpose which is parked in Government account under Civil Deposit. The amount so parked shall be further transferred to in favour of the account of Apex bank. After completing the codal formalities by the committee, the amount shall be further released to the beneficiaries on back end basis. The funding pattern and break-up of expenditure under the scheme is as under:-

1. An amount of Rs.200.00 lakhs shall be proportionately be divided in various districts as per the number of Home stay operating as per record.
2. An amount of Rs.200.00 lakh shall be for purchase of adventure tourism equipments to be purchased centrally.
3. Rs.100.00 lakh shall be earmarked for bakery and patisseries.
4. In every district a committee comprising of an Executive magistrate, APEX Bank branch manager and District Tourism Officer of the district will be constituted. The Payment will be back-end, i.e, total payment will be released by bank after completion of the project and inspection by the committee for Sl.No.1 & 3 above.



- (i) APST Certificate to be furnished
- (ii) Permanent Resident Certificate (PRC) to be furnished

**Mode of Subsidy:-**

- The maximum subsidy amount under the scheme will be Rs. 500 lakhs to each selected beneficiary.
- The bank finance under the scheme will be limited to 40 % of the project cost.
- Contribution by the beneficiary shall be 20% of the project cost.
- The bank loan so availed by the beneficiaries shall be re-paid to the bank within a time frame of 3 (three) years.

In continuation to the office notification no. Tou(Dev)289/2012(Pt-II) dated 18<sup>th</sup> Sept 2015 following addition to the criteria for candidates availing CMPVY scheme under Adventure equipments and Restaurants/Food Court :-

1. Un- employed youths who have successfully completed their Tourism hospitality course or Hotel management courses from the recognized Institutions/ Boards to avail the CMPVY scheme.
2. Well recognized NGO groups/ individuals/Eco-tourism and Adventure tourism promoters including the tourism clubs who are actively involved in tourism related activities in the State.
3. Those candidates who have successfully completed training under Hunar-Se-Rojgar Tak scheme on House Keeping and Food & Beverage Services in the past may also be considered for availing the CMPVY subsidy scheme. The selection of the candidates must be based on their certificates issued by the department.

Individuals with Tourism Hospitality course or Hotel Management course may avail CMPVY scheme under Food Court/ Bakery etc. provided they undergo Hunar Se Rojgar Tak(HSRT) training conducted by the Department of Tourism.


